

## Privacy Notice

7C Solarparken AG and 7C Solarparken NV are a group of companies within the meaning of Art. 4 No. 19 GDPR. Within the areas of data storage and implementation of data protection provisions the 7C Solarparken AG exerts a controlling influence over the other companies. For the purposes of data protection, 7C Solarparken AG controls the processing of personal data in companies affiliated to the group. For the Group of companies a data protection officer is named who can be easily reached by each branch.

In this notice we will inform you about which data is collected when you visit our website and how it is used. You can also learn more about your rights. This website is operated by 7C Solarparken AG („7C“, "us" or "we"). Further details can be found in the impressum.

### I. Data processing

#### *1. Visiting our website*

Generally, we do not identify visitors to our website. When you visit our website, we collect the following information that the browser transmits to our server, which is then temporarily stored:

- the IP address of your computer
- date and time of access
- name and address of the requested file
- transferred data volume
- report whether the retrieval was successful
- identification data of the browser and operating system used
- the name of your internet service provider

This data is processed in order to technically facilitate the use of the website. We use browsing data of our users for creating aggregated statistics (so that statistics do not show data about a single user but only about the collected data of a number of users), to learn what is of interest to users in order to improve our websites and offering. We also use the browsing data for maintaining or restoring the security of our offer or to detect and correct technical defects and errors.

#### *2. Processing of personal data*

Personal data will only be processed by us if you provide us with it voluntarily, e. g. via our contact form or by e-mail. If you provide us with personal data, it will be used for the purpose of handling your enquiry or to provide you with access to the services you have requested (such as evaluating your application for a position at 7C). The transferred personal data will not be connected with browsing data collected during your visit (see section 1.).

### *3. Cookies*

We use so-called cookies to enable and facilitate the use of our website. Cookies are small text files that enable our website to store information on your computer and retrieve it later (e. g. when you visit our website again). The use of cookies, for example, makes it possible to "remember" the language you chose to present our contents to you.

Our cookies do not allow us to identify you personally, but only to identify your computer temporarily. You can deactivate or block the storage of cookies in your browser generally or only for our site. You can find out how to do this in the help function of your browser. However, deactivating or blocking cookies may lead to restrictions regarding the usability of our website.

### *4. Data processing by third parties*

On our site we implement a frame by Deutsche Börse AG ("Börse Frankfurt"). When using this frame, Frankfurt Börse collects data in accordance with its privacy policy. You can view it here: <http://en.boerse-frankfurt.de/privacy>. According to this privacy policy your data can be provided to third parties by Frankfurt Börse and will especially as a general rule be stored in the USA by Google inc ("Google"). Google also collects data in accordance with its privacy policy, which can be consulted here: <https://www.google.com/policies/privacy/> For storage in the United States, Google's self-certification according to the Privacy Shield provides an appropriate level of data protection.

If you do not agree with this data processing, you can take several measures which are explained in the privacy policy of Frankfurt Börse or you can deactivate Cookies (cf. supra), deactivate JavaScript in your browser or install a tool such as Ghostery (<https://www.ghostery.com/>). You can find out how to do this in the help function of your browser. However, this may lead to restrictions on the usability of our website.

### *5. Disclosure of data*

We use service providers which support us to provide our services on this website. These service providers process data only in accordance with the instructions and under the control of Encavis and exclusively for the purposes described in this privacy policy.

### *6. Retention of data*

We only store personal data for as long as it is necessary for the provision of the services you require.

Data collected while browsing our website and which may be legally considered personal data (such as the complete IP address) will be stored for a period of time with a maximum of seven to fourteen days unless an exceptional event requires a longer period of storage (e. g. after a hacker attack).

Data without personal references can be stored permanently.

## **II. Your rights and contact**

### *1. General rights*

You can request information about the data stored on your person by us and you are entitled to receive the data provided by you in a common and machine-readable format. Furthermore, in justified cases, you may also request the deletion, correction or limitation of the processing of your data. If your personal data is transferred to a country outside the EU, that does not provide adequate protection, you may request a copy of the contract that ensures adequate protection of personal data.

## *2. Revocation of your consent*

When you have given your consent to the processing of personal data concerning you on the website, you can revoke your consent at any time with effect for the future.
